PROPOSAL INFORMATION

Conference Format

The 2026 Western Conference on Safety starts on Monday morning and ends Tuesday afternoon. Sessions on these days will focus on either occupational health, safety. High-level viewpoints are welcome as well as 'how-to" approaches or case studies. Interactive sessions that include participants in hands-on learning will be given special consideration. Sessions range from 75 to 90 minutes in length.

- Provide an overview detailing your presentation. Maximum length is 1 page. Do not submit Powerpoint presentations, brochures or promotional material. A link to a video clip of you presenting is optional but welcome.
- 3. Submit your application to the address or email shown below no later than October 1, 2025. Email submissions are preferred.
- 4. Preference will be given to session of most interest to the delegates. All persons making a submission will be informed of the results of the steering committees review of their submission.
- 5. Incomplete submissions will not be considered.
- 6. No more than 3 submissions from one speaker please.

CONFERENCE EXPENSES

All selected speakers will receive complimentary conference registration (valued at \$595). The conference has a limited budget available as payment for travel expenses for out of town speakers. Reimbursement for travel may be possible depending on distances, costs involved, popularity of session, budget remaining etc.
